ImagePerfect[™] 5905 Chalkboard Film is a calendered vinyl with a waterproof, permanent adhesive system. It has been specially designed for use in transforming surfaces into blackboards and for recovering existing blackboards. For use with (contemporary) chalk ink/chalk pens.

ImagePerfect[™] 5905 Chalkboard Film is a calendered vinyl with a smooth, matt finish that is suitable for use with (contemporary) chalk ink/chalk pens. It has been specially designed for use in transforming surfaces into blackboards and for recovering existing blackboards. It will be used in some retail locations and in many lifestyle business locations, such as bars, restaurants, cafes, hotels, casinos, sports arenas, etc, for the creation of changeable, vibrant messages. The adhesive has a low initial bond to enable repositionability but builds over 24 hours to form a permanent, waterproof bond on most substrates. It is compatible with most brands of chalk ink/chalk pen. Examples of brands already tested and verified would include Schneider Deco-Marker 260, Schneider Deco-Marker 265, Edding 4090, Schneider Maxx 265 (and many more), but it is recommended that the compatability and cleaning properties of the pen be tested on a small (ideally hidden) area of the substrate prior to complete use. The chalk ink can be removed from the surface with IP Surface Cleaner and a clean, soft cloth.
