- 2. EN ISO 11925-2:2020 Reaction to fire tests-Ignitability of building products subjected to direct impingement of flame-Part 2: Single-flame source test.

### Mounting and fixing (For EN 13823:2020):

As per client's requirement, the sample was self-adhesive on the substrate (test substrates is calcium silicate board meets the requirement of EN13501-1 of Class A2-s1,d0, the density of 900 kg/m³ and thickness of 10mm).
